Release and Waiver of Liability

PLEASE READ CAREFULLY! THIS IS A LEGAL DOCUMENT THAT AFFECTS YOUR LEGAL RIGHTS!

This Release and Waiver of Liability (the "Release") executed on this _____ day of _____ 20____ by _____, a minor child (the "Volunteer and Guardian"), and _____, the parent having legal custody and/or the legal guardian of the Volunteer and Guardian (the "Guardian"), in favor of Northern Michigan Horse Rescue and Rehabilitation, a nonprofit corporation, its directors, officers, employees, and agents ("NMHRR"). The Volunteer and Guardian desires to work as a Volunteer and Guardian for NMHRR and engage in the activities related to being a Volunteer and Guardian (the "Activities").

The Volunteer and Guardian and Guardian hereby freely, voluntarily, and without duress executes this Release under the following terms:

1. **Release and Waiver.** Volunteer and Guardian and Guardian does hereby release and forever discharge and hold harmless NMHRR and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer and Guardian and Guardian's Activities with NMHRR. Volunteer and Guardian and Guardian understands that this Release discharges NMHRR from any liability or claim that the Volunteer and Guardian and Guardian may have against NMHRR with respect to any bodily injury, personal injury, illness, death, or property damage that may result from Volunteer and Guardian's Activities with NMHRR, whether caused by the negligence of NMHRR or its officers, directors, employees, or agents or otherwise. Volunteer and Guardian also understands that NMHRR does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

2. **Medical Treatment.** Volunteer and Guardian does hereby release and forever discharge NMHRR from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer and Guardian's Activities with NMHRR.

3. **Assumption of the Risk.** The Volunteer and Guardian understands that the Activities included work that may be hazardous to the Volunteer and Guardian, including, but not limited to, injury from working with the equines being rescued and/or rehabilitated, physical labor, and transportation to and from NMHRR.

Volunteer and Guardian hereby expressly and specifically assumes the risk of injury or harm in the Activities and releases NMHRR from all liability for injury, illness, death, or property damage resulting from the Activities.

4. **Insurance.** The Volunteer and Guardian understands that, except as otherwise agreed to by NMHRR in writing, NMHRR does not carry or maintain health, medical, or disability insurance coverage for any Volunteer and Guardian.

Each Volunteer and Guardian is expected and encouraged to obtain his or her own medical or health insurance coverage.

5. **Photographic Release.** By selecting the YES option on the Volunteer and Guardian Form, Volunteer and Guardian do hereby grant and convey unto NMHRR all right, title, and interest in any and all photographic images and video or audio recordings made by NMHRR during the Volunteer and Guardian's Activities with NMHRR, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

6. **Termination of Volunteer Status.** Volunteer and Guardian expressly agrees that any acts of cruelty or use of actions that prevent other Volunteers from performing their duties may result in immediate termination of Volunteer Status.

7. **Other.** Volunteer and Guardian expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Michigan and that this Release shall be governed by and interpreted in accordance with the laws of the State of Michigan. Volunteer and Guardian agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
